



ASSEMBLY INSTRUCTIONS:

1. Line up the center hole at the top of the **SHIELD** with the center **ATTACHMENT HOOK** on the **VISOR** and push until it snaps into place.
2. Repeat this action for the remaining 4 **ATTACHMENT HOOKS** and holes.
3. Remove the adhesive backing from the **COMFORT FOAM** strip and apply it to the inside edge of the **VISOR**, where it will be in contact with your forehead.
4. Push the holes of the **RUBBER STRAP** over the two large pegs that are on the back right and left side of the **VISOR**. Adjust the strap holes used to achieve a comfortable fit.

The 180-degree face shield provides best in class protection. Its design features an enclosed top that helps prevent anything entering from above. The anti-fog shield includes two small ports to allow for airflow, which finds the perfect balance between quality, comfort and protection for its users. The face shield includes a 1/8" thick closed cell comfort foam to rest on the users' head allowing for maximum comfort and stability. The strap is made with allergy friendly non-latex rubber which is FDA approved. The face shield is adjustable and can fit around heads, hats, bump caps and helmets. The visor, strap and shield are reusable and can be easily cleaned or replaced. All components of the face shield are proudly manufactured and assembled in the USA.

RECOMMENDED CLEANING:

The face shield can be cleaned in peracetic acid or in a disinfecting process. Extreme heat may damage or warp the shield. Instead of cleaning the shields, replacement shields can be bought in single packs or bulk to snap into the user's visor. If the cleaning process damages or ruins the foam forehead bumper guard, replacements can also be purchased.
